**Subject.-** Advertisement Notice for the post of Fireman, Fireman Driver, Fireman Ministerial, and Sweeper (Safaiwala) in Ladakh Fire and Rescue Service.

Online applications are invited from eligible Residents of the Union territory of Ladakh for the following posts in Ladakh Fire and Rescue Service against the vacancies and in the Pay Level as shown against each.

The detailed terms and conditions with regards to eligibility, educational qualification, age, mode of recruitment, reservation, etc are as follows:-

- 1. Essential Qualifications:-** The essential educational qualification and age prescribed for the above-mentioned posts are specified in Annexure-"A".
- 2. Resident of the Union territory of Ladakh:** - The applicant shall be a Resident of the Union Territory of Ladakh as per the provisions of the Administration of the Union territory of Ladakh, Order No. 12-LA (LD) of 2021 Dated: 04-09-2021 and shall have a valid Resident Certificate issued

by the Competent Authority, by or before the last date of submission of the application form.

3. **Reservations and relaxations:** - Reservation will be in accordance with the provisions of the Union territory of Ladakh Reservation Rules as amended vide the Administration of the Union territory of Ladakh, Social Welfare Department, S.O-14 Dated 23<sup>rd</sup> April 2020.
  - a. Candidates seeking consideration under Reserved Categories must ensure that he/ she possess a Valid Category Certificate by or before the last date of submission of the application form.
  - b. Candidates may note that their candidature will remain provisional till the genuineness of the Reserved Category Certificate is verified by the appointing authority.
  - c. Candidates are cautioned to note that in case a claim for reservation is made on the basis of false/fake/fraudulent certificate, his candidature shall be canceled abinitio and legal action under the relevant law will be taken against the applicant.
4. **Mode of recruitment:-** The selection process prescribed for the posts of Fireman, Fireman Driver, and Fireman Ministerial are specified in Annexure-"B-1" and the selection process prescribed for the post of Sweeper (Safaiwala) is specified in Annexure-"B-2".
5. **Admit card:** - Admit card for any stage of examination will not be sent by post. Facilities for downloading admit cards will be provided.
6. **Examination center:** - Each district will ordinarily have one center for the conduct of recruitment tests.
7. **Link for submission of Online application:** The link for submission of the online application form for the post will become active/live on 27-04-2022 and will remain active/ live till 18-05-2022 (5:45 PM). Eligible candidates are requested to fill out the application form by visiting the link <https://ladakhpolicerecruitment.in> by or before the last date for submission of the online application form.
8. **Application Fee:-**
  - a. Fee payable:
    - i. **For the post of Fireman, Fireman Driver and Fireman Ministerial:-** Rs 500/- (five hundred rupees only)
    - ii. **For the post of Sweeper (safaiwala):-** Rs 300/- (three hundred rupees only).
  - b. Fees can be paid only by online mode through Net Banking, Credit Cards, Debit Cards, or UPI.
  - c. Application received without the prescribed fee shall not be considered and summarily rejected. No representation against such rejection will be entertained. Fee once paid shall not be refunded under any circumstances nor will it be adjusted against any other examination or selection.

- d. All disputes related to refund of excess payment, if any, are the subject matter of the Board. Candidates are advised to apply for refund of excess payment, if any, to the Board with documentary evidence.
9. The number of vacancies notified is tentative.
  10. The recruitment shall be subject to the provisions of Ladakh Fire and Rescue (Subordinate) Service Recruitment Rules, 2021, and Standing Order issued under the provisions of the said Rules.
  11. The decision of the Board in all matters relating to eligibility, acceptance or rejection of the applications, penalty for false information, conduct of examination(s), allotment of examination centers and preparation of merit list, debarment for indulging in malpractices would be final and binding on the candidates and no enquiry/ correspondence will be entertained in this regard.
  12. In addition to the Admit Card/Slip, it is mandatory to carry at least two passport size recent color photographs, Original documents/testimonials and one set of photocopies of the documents/ testimonials and Original valid Photo-ID proof such as Aadhaar Card/ Printout of E-Aadhaar, Voter's ID Card, Driving License, PAN Card, Passport, School/ College/University I-Card, etc. During the PMT/PET test.
  13. The candidates shall have to appear in the prescribed tests at their own expense on the date and venue to be notified by the Board.
  14. The candidates are required to undergo the prescribed medical test as per the provision of relevant rules/ orders.
  15. The examination details will be notified separately.
  16. The selected candidates shall be required to undergo prescribed basic training.
  - 17. Important Instructions to Candidates:-**
    - a. Before applying, candidates are advised to go through the instructions given in the notice of examination very carefully.
    - b. The Board will not undertake detailed scrutiny of applications for the eligibility and other aspects at the time of test/ examination and, therefore, the candidature will be accepted only provisionally. The candidates are advised to go through the requirements of educational qualification, age, etc. and satisfy themselves that they are eligible for the post(s). Copies of supporting documents will be sought at the time of Document Verification. When scrutiny is undertaken, if any claim made in the application is not found substantiated, the candidature will be canceled and the Board's decision shall be final and binding.
    - c. When the application is successfully submitted, it will be accepted 'Provisionally'. The candidate should take a printout of the application form and submit the same at the time of Documents Verification. The candidates are further advised NOT to submit the hard copies of the online application form in the office of the Board either in person or by post/email.
    - d. Only one online application for a given post is allowed to be submitted by the candidate. Therefore, the candidates are advised to exercise due diligence at the time of filling their online Application Forms. In case, more than one application of a candidate is detected for the same post, the Board

- will consider latest application. If a candidate submits multiple application forms for the same post and appears in the examination (at any stage) more than once for the same post his/ her candidature will be cancelled and legal action will be initiated against such candidate(s).
- e. In case of fake/ fabricated application, such candidate(s) are liable for suitable legal action under cyber/ IT Act.
  - f. **Before applying, candidates are advised to go through “the instructions for filling-up the application form” given on the application portal, very carefully.**
  - g. **Candidates are advised in their own interest to submit online applications much before the closing date and not to wait till the last date to avoid the possibility of disconnection/ inability or failure to login to the online application portal on account of heavy load on the website during the closing days.**

**I. Mode of recruitment for the Post of Fireman, Fireman Driver and Fireman Ministerial:-** The selection process for the posts of Fireman, Fireman Driver and Fireman Ministerial will consist of the following compulsory tests in the given order:

**I. Physical Measurement Test:-** The candidate processing basic eligibility criteria viz age, educational qualification, etc, will be subjected to the Physical Measurement Test. Standards of Physical measurement will be as provided in Schedule-II(A) of the Ladakh Fire and Rescue (subordinate) Service Recruitment Rules 2021, reproduced below:-

Height male = minimum 162 cms

Height female = minimum 152 cms

Chest (only for male candidates):-

Unexpanded = minimum 81 cms

Expanded = minimum 85 cms.

**Note-1:** candidates who do not qualify the Physical Measurement Test will be disqualified and will not be allowed to participate in the remaining recruitment process.

**Note-2:** No rounding off will be allowed.

**II. Physical Endurance Test:-** Physical Endurance Test will be taken only of those candidates who qualify the Physical Measurement Tests. The Physical Endurance Test will be of qualifying nature and will consist of the following events:

S. No	Name of the activity
01	Long run (1600 meters for male within 7 minutes and 1000

	meters for female within six minutes and thirty seconds).
02	Load Carrying Test:- 91.44 meters with load (63.5 kgs for male and 50 kgs for female) in one minute.
03	Bent Knee Situps (25 Bent Knee situps for males and 20 Bent Knee Sit-ups for females) in 90 seconds.
04	Walk on a beam of 7 meters with a load of 17 Kgs, (in three attempts).
05	Vertical rope:- Minimum 04 meters from ground level.

The details of the above events are as follows.

- a. **Event-1:- Long run (1600 meters for male and 1000 meters for female).** This event will be of qualifying nature and any candidate who completes the long run, 1600 meters in case of male candidates within 07 minutes and 1000 meters in case of female candidates within 6 minutes and 30 seconds respectively will qualify the event.
- b. **Event-2:- Load Carrying Test:- 91.44 meters with load ( 63.5 Kgs for males and 50 Kgs for females):-** The Load Carrying Test will be of qualifying nature and any candidate who completes run of 91.44 meters with load (63.5 Kgs for male and 50 Kgs for female) within 1 minute will qualify the event.
- c. **Event-3:- Bent Knee Sit-up:-** This event comprises of performing Sit-Ups (Lie faceup on the floor with your knees bent and feet flat. Stack your forearms in front of your chest. Now raise your torso to a sitting position in one fluid movement. Slowly lower your torso back to the starting position). The candidates shall perform twenty-five Bent Knee Sit-Ups ( in case of male candidates ) or 20 Bent Knee Sit-Ups ( in case of female candidates) within 90 seconds to qualify the event.
- d. **Event-4:- Walk on beam with a load of 17 Kgs:-** This event comprises of walking on a beam, secured to the level floor, with a load of 17 Kgs. The beam will be seven meters long and eight cms wide. The candidates shall walk the entire length of the beam carrying a load of 17 Kgs without falling off or stepping off the beam, in three attempts, to qualify the event.
- e. **Vertical Rope:-**This event comprises of climbing a rope to a height of minimum of four meters from the ground level. Candidates shall climb the rope to a minimum height of four meters from the ground level to qualify the event.

**Note 1:-** Candidates shall qualify each event separately.

**Note 2:-** Only Candidates who qualify the preceding event will be eligible for the next event.

**Note 3:-**There will be no appeal against disqualification in the above events. No candidate will be allowed to retake the test in any case.



- III. **Scrutiny of original documents/testimonials:-** Candidates who qualify the Physical Endurance Test shall submit their original documents/testimonials, along with self-attested photocopies of the documents/testimonials, for scrutiny. (The scrutiny is provisional and all documents/testimonials will be subjected to verification through the concerned authority). The candidates, who are supposed to furnish various certificates issued by or before the prescribed cutoff date, will be required to produce them at the time of document verification or as may be sought by the Board, failing which the candidature of such candidate will be canceled by the Board.
- IV. **Driving test (50 marks):-** The Driving test is applicable only for the post of Fireman Driver. The Board will frame the detailed syllabus for the test in light of relevant rules in force and will conduct the driving test as per the latest driving test guideline formulated by the relevant department in the UT Administration and may co-opt experts from the relevant department. The test will carry a maximum of 50 marks.
- V. **Computer test (50 marks):-** the Computer test is applicable only for the post of Fireman Ministerial. The test will carry a maximum of 50 marks.
- VI. **Written examination (objective type):-** The Recruitment Board will conduct the written examination. All candidates who have qualified the Physical Endurance Test and whose documents/testimonials have been scrutinized and found correct will be put through a written examination which will be of 80 minutes duration. The written examination will consist of one objective type paper containing 100 questions and each question carrying 01 mark. There will be no negative marking for marking wrong answers. The question paper for the written examination will be in English only. The question paper will be of matriculation level. The syllabus for the examination is as follows.

**Mode of recruitment for the Post of Sweeper (Safaiwala):-** The selection process for the posts of Sweeper (Safaiwala) will consist of the following compulsory tests in the given order:

- I. **Screening Test:-** The candidate processing basic eligibility criteria viz age, educational qualification, Residence, etc will be subjected to the Screening Test. The Screening Test will be common to all the trades. The Screening Test will be qualifying in nature. In the case of male candidates, the candidate who completes the 1600 meters run in 7:30 minutes will be considered qualified in the Screening Test. In the case of female candidates, the candidate who completes the 1000 meters run within 7 minutes and 30 seconds will be considered qualified in the Screening Test.
- II. **Scrutiny of original documents/testimonials:-** Candidates who have qualified the Screening Test shall submit their original documents/testimonials, along with self-attested photocopies of the documents/testimonials, for scrutiny. (The scrutiny is provisional and all documents/testimonials will be subjected to verification through the concerned authority).
- III. **Trade Test:-** The candidates who have qualified the Screening Test and whose testimonials have been scrutinized and found correct, will be subjected to the Trade Test. The Board will conduct the Trade Test of the candidates. The test will be for a maximum of 100 marks.
