Whereas, PHQ UT Ladakh vide the above advertisement notice has notified 264 vacancies in Executive, Armed/IRP, HG/CD/SDRF of Ladakh Police as per the below vacancies:

Whereas, it has come to the notice of Police Headquarter UT Ladakh that Ministry of Personnel, Public Grievances & Pension, Department of Personnel and Training has issued the following;

- I) OM No. 36039/1/2019-Estt (Res) dated 31 January 2019.
- II) Letter No. 43011/11/2022-Estt9- (Res-II) dated 19 September 2022.

Whereas O.M No. 36039/1/2019-Estt (Res) dated 31 January 2019, states at Para 6.3 "Where in any recruitment year any vacancy earmarked for EWS cannot be filled up due to non-availability of a suitable candidate belonging to EWS, such vacancies for that particular recruitment year shall not be carried forward to the next recruitment year as backlog".

Whereas the Ministry vide letter No. 43011/11/2022-Estt9- (Res-II) dated 19 September 2022 has further clarified that "wherein any recruitment year any vacancy earmarked for EWS cannot be filled up due to non-availability of a suitable candidate belonging to EWS, such vacancies for that particular recruitment year shall not be carried forward to the next recruitment year as backlog. A further attempt in the same recruitment year to fill the EWS vacancy is desirable. Thereafter, the unfilled vacancies may be filled up, treating them as unreserved provided it does not result in excess representation in general category beyond the number added on account of non-availability of EWS candidate. If it results in excess representations, it may be diverted to the category in which shortfall exists".

Therefore, in light of the above O.M issued by Ministry of Personnel, Public Grievances & Pension, Department of Personnel and Training, the backlog vacancy in EWS quota advertised vide PHQ UT Ladakh advertisement No. 01 of 2023 dated 07-09-2023 is treated as unreserved.
