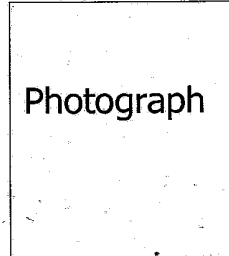
3. **Allowances-**(i) Special duty allowances (SDA)10% of the Basic pay

4. The Police person selected for appointment on deputation will be governed by the standard term of deputation as contained in the DP&T OM No.6/8/2009-Estt. (Pay.II) dated 17.6.2010 & 01.03.2011 and DP&T OM No.6/5/2012-Estt(Pay.II)dated 30.11.12 and as amended from time to time .

Applications of only such police personnel will be considered as are routed through proper channel and are accompanied with (i) Cadre clearance (ii)Bio-data,as in the pro-forma enclosed as Annexure-II (iii) photocopies of APARs/annual remarks for the last five years (year 2017 to 2021)(iv)vigilance clearance (v)Integrity Certificate and (vi)statement giving details of major or minor penalties imposed, if any during the last 10 years.
6. The Period of deputation is two years and shall be extended up to five years based on their performance and as per rules.
