Through the medium of this notice, it is to inform the candidates who have qualified the PMT/PET tests for the posts of Fireman, Fireman Driver and Fireman Ministerial in Ladakh Fire and Rescue Service and Warder/Warder Driver in Ladakh Prisons Department that the written examination for the posts will be held on 27-11-2022. Candidates are advised to download their admit cards from https://ladakhpolicerecruitment.in/ w.e.f. 19-11-2022 to 26-11-2022. Candidates who have Qualified PET/PMT for Multiple post are advised to download separate admit cards for each post.

Further it is informed to the candidates that there will be a common paper for the post of Fireman, Fireman Driver and Fireman Ministerial in Ladakh Fire and Rescue

The timings of the examination are as under:-

- 1. Fireman, Fireman Driver and Fireman Ministerial 1100hrs
- 2. Warder/ warder Driver 1400 hrs

The venue of the examination will be as under:-

- 1. District Police Line Choglamsar Leh for candidates who have opted District Leh as their centre.
- 2. District Police Line Kurbathang Kargil for candidates who have opted District Kargil as their centre.

Note:-

The candidates are advised to adhere to the guidelines prescribed below:-

- Candidates should report to the examination centre on the scheduled date and time as provided in the admit card.
- 2. Candidates should bring a Print out of valid Admit Card issued by the Board.
- 3. Candidates should report 2 hours before the scheduled time of the exam.
- 4. Candidates should bring the original ID at the time of the test.
- 5. Candidates should carry black ball pen only to fill the OMR Answer Sheet.
- Candidates are prohibited to carry purse, valuables, phone, electronic gadgets etc.
 and if any candidates are found to be in possession of the above, such candidates
 will be debarred from the examination and from the entire recruitment process.

The candidates should obey the instructions given by the members of the board and any other supervisory officers during the examination.
