Subject:- Provisional Selection List and Waiting List for the post of Sweeper(Safaiwala) in Ladakh Fire and Rescue Service.

Whereas, the Ladakh Police Subordinate Service Recruitment Board constituted vide, Home Department, UT Ladakh, Order No:47-Home of 2021, dated:14-10-2021 was appointed as the Board for making recruitment to the Non-Gazetted posts of the Union territory of Ladakh, Fire and Rescue (Subordinate) Service, vide Home Department, UT Ladakh, S.O 16 of 2022, dated: 16th February, 2022.

Whereas, the Police Headquarters Ladakh vide Advertisement No. 02 of 2022 dated 22-04-2022 notified two (02) post of Sweeper(Safaiwala) in Ladakh Fire and Rescue Service (OM(GEN)=01, ST=01, total=2).

Whereas, Police Headquarters, UT Ladakh, engaged M/S e-soft Consulting Ltd, Hyderabad for conducting the entire Recruitment through the Transparent Recruitment Process.

Whereas, the Board conducted the selection process as under:-

- a. Screening Test (1600 meter run for male and 1000 meter run for females in 7 minutes and 30 seconds) and Document Verification from 11-10-2022 to 22-10-2022. The result of the Screening Test was declared on the test centre.
- b. Trade Test from 11-04-2023 to 12-04-2023.

Whereas, the result of provisional document verification was notified vide Office of the Chairman, LPSSRB, Notice under endorsement No: LPSSRB/2023/788-97, dated: 10-05-2023.

Whereas, taking into account the aforesaid aspects, the Board, in consultation with e-soft Consulting Ltd, prepared the Roll Number wise merit of the candidates, category wise selection list and general waiting list. The Board submitted the same to

the Police Headquarters Ladakh vide letter under endorsement No: LPSSRB/2023-844, dated: 06-06-2023.

Consequent upon the above, the provisional Selection List and Waiting List of the candidates against the available posts are given in Annexure-"A" and "B" respectively, to this Notification

The roll number wise result of all the candidates who appeared for the exam is enclosed as Annexure-"C" to this Notification.
