2. Whereas, vide PHQ UT-Ladakh Memorandum No.PHQ/Pers/Post-Ct/2023/3848-52 dated 08.03.2024, the selected candidates were issued Offer of Appointment against the post of

Constable in Executive/Armed/IRP/HG/CD/SDRF in Ladakh Police.

3. Whereas, vide PHQ UT-Ladakh order No.184 of 2024 dated 11.03.2024, the selected candidates were issued Provisional Appointment against the post of Constable in

Executive/Armed/IRP/HG/CD/SDRF in Ladakh Police.

4. Whereas, Superintendent of Police, District Leh/Kargil/C.O IRP 25th Bn. vide their letter No. and dates shown against each have intimated that the below mentioned selected candidates are not willing to join the Police Department against the post of Constable in Executive/Armed/IRP/HG/CD/SDRF in Ladakh Police and have not accepted the Offer of Appointment and also submitted their un-willingness in writing in the shape of affidavit with specific reasons mentioned therein.
