- Whereas**, vide above referred Selection Notice dated 11.01.2024, the Ladakh Police Service Selection Recruitment Board (LPSSRB) had issued selection list in favour of following candidates among others against the post of Constables in Telecom Cadre in Ladakh Police in the Pay Level-2 of Pay Matrix (Rs.19900-63200).
