Each appointee shall give an undertaking in the shape of affidavit to the effect that if on verifications, his/her Qualification/date of birth/Reserved Category Certificates from the concerned issuing authorities is found fake/forged, his/her appointment as Constable shall be deemed to have been cancelled ab-initio and the legal action as warranted under rule shall be initiated against him/her.

- The salary of the appointees shall not be drawn and disbursed to him/her unless satisfactory report in respect of the genuineness of his/her qualification/ relevant category certificate / date of birth and other pre-requisite certificate (s) is received from the concerned issuing authority.
- 3. Further, seniority shall be as per the merit secured in the selection list of Constables in Telecom Cadre UT-Ladakh prepared and submitted by LPSSRB vide letter No. LPSSRB/2024/1789 dated 11.01.2024.
- 4. The appointment of the candidates shall be governed by "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.

The Selected candidates should report to the concerned units within (21) days from the date of issuance of this order.
