Order No. /3//2023 Dated :- /3 /03/2023

Whereas in reference to NIT no 05 of 2022 dated 25/04/2022 floated by Ladakh Police for the supply of A Grade Hard Coke, in which 08 bidders had participated out of which 06 have qualified. During the technical evaluation of the bidders, M/S Abdul Khaliq Mandoo has been declared as an L1 firm and subsequently, the supply order vide endorsement No.PHQL/Prov-1/HC/SO/17328-34 Dated:25/08/2022 has been issued in favour of the said firm, with the request to complete the supply of the same within (30) days from the issuance of the supply order as per the condition laid down in the instant tender. However, the said firm failed to give the supply of Hard Coke to Ladakh Police in the stipulated time frame. Further, in this regard, several notices have been served to the successful bidder for immediate supply of the Hard Coke to Ladakh Police as the winter season already started and he has been also telephonically requested to complete the supply order immediately, but, despite several notices served as well as a verbal request made to the M/S Abdul Khaliq Mandoo to give immediate supply to Ladakh Police,

Whereas the said firm did not bother to reply to any of the notices served by this Hqrs. for which this headquarters had served a Final Notice requesting the said firm to complete the supply order within (03) days after issuance of the final notice, in which the said firm has been asked to reply to the final notice served, otherwise, appropriate action as warrant under rules shall be taken up by this office for violation of terms and conditions laid down in the instant tender, as well as breaching the code of integrity, as per rule (175) and is because of the failure on the part of the said firm that Ladakh Police had not only to face a lot of problems to make proper arrangements but all inconveniences have been faced in the administration process as well.

Whereas on dated 06/11/2022 M/S Abdul Khaliq Mandoo, L-1 vendor submitted a written reply to the final Notice, wherein, the said firm has accepted his failure to give the supply of Hard Coke to Ladakh Police and conveyed that he is not in a position to give the supply of Hard Coke to Ladakh Police in near future, and is ready to face consequences/action for laxity and false assurances/ violation of terms and conditions as laid in the instant tender by Ladakh Police, thereby creating the inconvenience to Ladakh police.

Whereas show cause notice was served to M/S Abdul Khaliq Mandoo by giving reasonable opportunity to reply in writing within (05) days that why appropriate action under rules shall not be taken against him.

Therefore, after careful consideration and perusing all relevant records including Notices, Final Notice as-well-as Show Cause Notice served upon the firm namely M/S Abdul Khaliq Mandoo, it has been observed that the firm has not only failed to provide the supply of the Hard Coke to Ladakh Police but has also proved its incapability for delivering over the contract agreement by violating all the norms related to procurement.

As such, it is hereby ordered that:-

- 1. M/S Abdul Khaliq Mandoo is barred for a period of (01) year from the date of issue of this order from participating in any tender floated by Ladakh Police.
- 2. The security deposit in the shape of CDR of an amount of Rs 1,57,740/- (one lakh fifty-seven thousand seven hundred forty only)deposited by M/S Abdul Khaliq Mandoo shall be forfeited with immediate effect as a penalty under rules and shall be remitted in the Govt Treasury.

In view of the above, the debarment period of the said firm shall be reckoned from the date of issue of this order and shall end on 12/03/2024.
